Individual Membership (One vote at AGM)	\$10.00
Family Membership (Up to 2 votes at AGM)	\$15.00
Self Advocate/ Person with ASD (One vote at AGM)	\$0.00 No Charge
Friend of Autism Yukon (No Votes - see below)	\$5.00

You can become a member at anytime throughout the year. Voters must be at least 18 years old. Membership fees are due at time of registration/renewal and must be current (paid) to be considered in good standing for the annual general meeting.
